Dues for the membership year beginning January 1, 2026, are due and payable on or before January 1, 2026, and are delinquent January 11, 2026.

Any member board or individual member submitting dues after February 14, 2026, for an existing member as of January 1, 2026, shall be assessed an additional KAR late fee of \$10.00 per member. The membership of any member delinquent in payment of such dues on March 31, 2026, shall automatically terminate on April 1, 2026.

New member dues are assessed from the date of licensure.

Special Assessments: The 2026 dues for NAR quoted above include a \$45.00 special assessment for the National Public Image Campaign. This fee is not prorated for new members.

New Broker/Company to the LMLS

In addition to the schedule above, New Brokers pay a Company Application Fee of \$500 when joining the LMLS.

All licensees with access to the MLS are required to pay MLS Fees. MLS Fees are due and payable on or before January 1 and July 1 of each year. Fees are delinquent if not paid by the due date. Subscribers owing Fees more than 10 days following the due date will incur a \$100 reactivation/late charge, and MLS privileges will be suspended. Participants (Brokers) who are delinquent will cause the suspension of MLS privileges for all Subscribers (Agents) in their company. MLS fees are non-refundable.
