Dues for the membership year beginning January 1, 2021, are due and payable on or before January 1, 2021. State and Local late fees apply if past due.

New member dues are assessed from the date of licensure.

This fee is not prorated for new members.

*In addition to the schedule above, New Brokers pay a Company Application Fee of \$500 when joining the LMLS.*

*All licensees with access to the MLS are required to pay MLS Fees. MLS Fees are due and payable on or before January 1 and July 1 of each year. Fees are delinquent if not paid by the due date. Subscribers owing Fees more than 10 days following the due date will incur a \$100 reactivation/late charge, and MLS privileges will be suspended. Participants (Brokers) who are delinquent will cause the suspension of MLS privileges for all Subscribers (Agents) in their company. MLS fees are non-refundable.*
